

In the Name of the Father and of the Son and of the Holy Ghost. Amen.

I, Remigius Deryckere, of the City of Deer Lodge, County of Powell, State of Montana, of the age of seventy-two years, and of sound and disposing mind and memory, and not acting under duress, menace, fraud, or undue influence of any person whatsoever, do make, publish, and declare this my last will and testament.

First: I direct that my body be decently buried and that at least fifty Masse be said for the repose of my soul, and that I be buried with Low Mass.

Second: I direct that my executor hereinafter named, as soon as sufficient funds are realized from my estate, shall pay my funeral expenses, the expense of my last illness, and all my just debts and liabilities.

Third: I give and bequeath to my brother Gustaf DeRyckere of Wynckel St. Elo, West Flanders, Belgium, the sum of one dollar (\$1.00); to my sister Juliana De Glorck (nee De Ryckere), of Iseghem, West Flanders, Belgium, the sum of one dollar (\$1.00); to my sister Mary Verdeure (nee De Ryckere) of Emelghem, West Flanders, Belgium, the sum of one dollar (\$1.00):

Fourth: All the rest and residue of my real estate, in the State of Montana, United States of America, whether the same be town lots, mining property or otherwise, I give and devise to St. Mary's Academy, an educational association, a Corporation of Leavenworth, Kansas, and to St. Joseph's Hospital of Deer Lodge, Montana, their successors and assigns forever; in trust, however, to hold the same for the purpose of promoting and establishing a Foundling House at Deer Lodge, Montana, or if one should have already been established at Deer Lodge, Montana, before the time of my death, then this property shall be kept and used for the purpose of benefitting and assisting said Foundling House; and if such Foundling House shall be established before the time of my death, or if said devisees in this paragraph mentioned, shall make arrangements, or if arrangements shall be made, for the establishment of such Foundling House at Deer Lodge, Montana, then it is my wish and will that my said devisees, to wit, the said St. Mary's Academy of Leavenworth, Kansas, and the said St. Joseph's Hospital, of Deer Lodge, Montana, shall have full power and authority, and they will hereby be given full power and authority, to sell and convey or otherwise dispose of, all the property that may come to them by virtue of this my last will and testament, for such sum and in such manner as may be best, and as may be a fair value of such property, and apply the proceeds thereof for the use, benefit and maintenance of the said Foundling House: and provided further that the devisees last aforesaid, their successors or assigns, shall be unable to construct such Foundling House before the 27th day of November, 1923, or if such shall not have been constructed before that time, their successors and assigns shall have and hold the abovementioned property, in trust equally, for the benefit and use of the school known as St. Mary's Academy, of Deer Lodge, Montana, and the Hospital known as St. Joseph's Hospital, of Deer Lodge, Montana, and said devisees, to wit, the St. Mary's Academy, of Leavenworth, Kansas, and St. Joseph's Hospital, of Deer Lodge, Montana, shall have full power, after the 27th day of November, 1923, to sell and convey, or otherwise dispose of said devised property or any portion thereof, and apply the proceeds thereof for the use, benefit, and maintenance of said St. Mary's Academy of Deer Lodge, Montana, and St. Joseph's Hospital, of Deer Lodge, Montana.

Fifth: All the rest and residue of my money and personal estate that I may have at the time of my death, after the payment of my just debts and funeral expenses, and such other charges as are herein provided for, I give and bequeath unto my hereinabove mentioned brothers and sisters, share and share

alike. This paragraph applies only to such money and property as I may have with me in Belgium at the time of my death.

Sixth: In case any of the herein mentioned real estate in the State of Montana, shall be sold previous to the time of my death, and converted into money or personal property, then it is my wish and will and I so direct that the same and any and all other money or property that I may own in Montana be given to the said school known as St. Mary's Academy in Deer Lodge, Montana, and the said St. Joseph's Hospital of Deer Lodge, Montana, in equal shares to be kept and used by them for their use and benefit, in the manner directed in paragraph four of this my last will and testament. This last paragraph is intended to apply only to such money as will be hereinafter realized from the sale of such real estate in the State of Montana, as I may now have or own, and to such other money and property as may be in Montana of mine at the time of my death.

Seventh: I hereby nominate and appoint the Very Reverend Victor Day, Vicar General of the Diocese of Helena, Montana, and Reverend Father De Siere of Butte, Montana, the executors jointly in Montana, the United States of America, without bonds, of this my last will and testament, to act in such capacity for the probate of this my last will and testament, in any probate court of said State of Montana. I hereby revoke all former wills by me made.
